If we reply to your email requesting you don't do a reading from a particular book, please know that we did everything possible to help you make it happen.

# If you are an author or illustrator who would like to do a recorded or live reading of your book:

We are granting you permission to read your titles online up to and including 31<sup>st</sup> July 2020. These virtual readings may be streamed live via digital platforms, or if recorded, posted in closed educational platforms. If a closed platform is unavailable, recorded videos of readings may be uploaded to YouTube as long as they are marked "Unlisted". Do let us know what you're doing by emailing pressoffice@euk.egmont.com so we can help you spread the word on social media.

### If you are an author who has received a request from an educator, bookseller or librarian to read your book online:

We are extending the ability to our authors and illustrators to grant permission to teachers, booksellers librarians to read their titles online up to and including 31<sup>st</sup> July 2020. These virtual readings may be streamed live via digital platforms, or if recorded, posted in closed educational platforms. If a closed platform is unavailable, recorded videos of readings may be uploaded to YouTube as long as they are marked "Unlisted". We ask that you ask the requestor to do the following, as conditions of this grant of permission:

- Mention the title of the book and the name of the author and/or illustrator as part of the video and that the reading is done with permission from Egmont Books

    - ✓ Title, author and ISBN of the book that is read

# If you are a bookseller who would like to stream a live online reading of an Egmont book:
